Graduation Guidance for Students with an IEP Receiving a Diploma

Legal Requirements from the <u>IDEA</u> and <u>Graduation Decisions for Students with Disabilities</u>

Requirements of a High School Diploma (Sec. 300.102 (a) (3) (iv))

A regular high school diploma meets the requirements of the Michigan Merit Curriculum. In Michigan, a student with an IEP may qualify for a personal curriculum depending on their Educational Development Plan, Transition Plan, and IEP.

Summary of Performance Requirements (Sec. 300.305)

When a student with an IEP graduates or ages out of special education, the school must complete and provide the student with a summary of their academic achievement and functional performance, which shall include recommendations on how to meet their postsecondary goals. Ideally, the student will use this document as a support when applying to jobs and/or post-secondary school.

Notice of Exit (Sec. 300.503)

Graduation from high school constitutes a change of placement, since the student will no longer be receiving special education services, which requires prior written notice.

Procedure:

☐ Complete a credit review to confirm the student is on track to graduate			
□ Do the following when completing the final IEP during the 12th grade year:			
☐ Complete Invitation: Address and deliver to student and parent and follow related transition requirements for a secondary transition IEP.			
Meeting Purpose: Be sure and include Check Secondary Transition and Change of Placement – Graduation as well as annual IEP or reevaluation IEP.			
The date for the end of the IEP: Graduation date, not a year from the date IEP was held.			
☐ Update the PLAAFP : Enter current information, continuing goals until the end of the year if appropriate.			
☐ Course of Study: Diploma			
☐ Transition Plan : Consider all special needs and/or outside agencies that will be involved in post-secondary placement. The school's responsibilities and services discontinue on graduation date.			
☐ Notice Page : The statement should clearly indicate that the student's services will be

discontinued on exit date if/when the student successfully completes graduation			
requirements resulting in a diploma.			
☐ Complete the Summary of Performance in EdPlan
